## Important Note

1. Any alteration/change in the names of the team members shall be intimated in writing by the team requesting such alteration/change positively to the Organizing Committee. However, any such alteration is permitted only once.
2. Each team shall consist only of three members, comprising two Mooters and one Researcher.
3. Once the competition commences, the team composition cannot be altered under any circumstances.
4. Inability of any team member to participate shall lead to disqualification of the team from the competition.
5. The composition of team members cannot be changed after registration except on approval of the organizing committee.
6. Once Registration is done no changes in names shall be allowed.
7. The Organizing Committee shall send a confirmation of participation email after verifying the entire process.
8. The participants may change their roles within their team only after prior intimation and approval of organizing committee.
9. Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claim of whatsoever nature shall be entertained thereafter.
10. The participants should not use any offensive or derogatory language during the entire event.
11. Failure to observe any of this rule shall lead to disqualification of the erring team.
12. There shall be no TA/DA ,accommodation or other expenses incurred in connection with the event shall be provided to the participants.
13. Details of all the rounds shall be intimated to the concerned students through mail.


